# Seven Steps to Divorce Healing

<b>1</b>	<b>Invigoration</b>	The death of one's family brings about <b>4</b> stages <ul style="list-style-type: none"><li>• <b>Denial</b> • <b>Anger</b> • <b>Grieving</b></li></ul> Vigorous physical activity helps lower stress and supports problem solving which leads to <b>Acceptance</b>
<b>2</b>	<b>Communication</b>	Learn to apply these skills <ul style="list-style-type: none"><li>• <b>Regulation of self-talk</b> • <b>Reframing</b> • <b>Persuasion</b></li><li>• <b>Influence</b> These skills enable articulation and comprehension of the problems, leading to creative solutions.</li></ul>
<b>3</b>	<b>Education</b>	<b>Believe solutions exist</b> and you will begin to see them <b>Books, tapes, professionals, support groups, self-help resources provide ideas.</b> Without ideas, the process grinds to a halt.
<b>4</b>	<b>Negotiation</b>	Most people rely on 1 or 2 negotiating strategies <b>Study, learn and apply the skills required to negotiate</b> Increase your options and you are closer to a creative win/win solution.
<b>5</b>	<b>Mediation</b>	<b>A professional mediator can help</b> When the lines of communication break down, mediators are trained in conflict resolution. <b>Attend sessions</b> even by yourself, to improve your communication skills.
<b>6</b>	<b>Enrichment</b>	<b>Consult a child psychologist</b> They can assist with <b>parenting enrichment and a parenting plan.</b> This will heal your child from the impact of the divorce and help meet their developmental needs.
<b>7</b>	<b>Litigation</b>	<b>The absolute last resort</b> If you have taken the time to methodically work through these steps properly, you can establish that <b>you have the skills and the willingness to work things out.</b>
